Neighbourhood of Brisbane towards Coast where many small proprietors occupied in agricultural pursuits, being exposed to marauding excursions of troublesome tribe of Natives called Ningi Ningi inhabiting numerous scrubs & swamps along seashore from Bribie Island to Wide Bay, requires protection as much as Country tendered for by Messrs Fitz & Connor. In Clarence District likewise Natives scarcely to be trusted 2 [Several pages of discussion re interactions between tribes of Aborigines & white settlers] Suggest if Government does not protect Fitz & Connor & others, likely organise own armed force. Preferable to station Section of Native Police under an active, courageous & intelligent Officer to possibly prevent effusion of much blood on both sides 3 Petitioners have sent in tenders for country but not yet in legal possession. Country is very distant. According to Mr Connor's own reckoning about 250 miles from this place. No Commissioner could live there till there is some station to furnish meat. Mr Connor intends moving out there after shearing. I am now proceeding to Dawson & its tributaries where there are 120 Blacks awaiting my report. My intention to go up McKenzie in April when horses recruited. If Messrs Fitz & Connor were only persons going out to so great a distance they could scarcely claim protection.
